The regular monthly meeting of the White County Housing Authority Board of Commissioners convened at 6:00 p.m., at White County Housing Authority Community Center, Crossville, IL.

Executive Director Pam Deig presented her reasons for the IMRF wages on the agenda. Last year the board approved bonuses for both her and Wendy Stone. Pam contacted IMRF to clarify if the regular deductions applied to the bonus checks and informed "No" by the IMRF representative. Therefore, when the board approved Year End Bonus checks for all employees, Pam processed the checks the very same way and reported the wages. In January 2023, the Executive Director received an Advice letter from IMRF regarding the (2) bonus checks and found out deductions should have applied to the bonus checks. Pam deducted the additional amounts owing for both her and Wendy from their paychecks over two pay periods. The wages reported for the year-end bonuses processed the very same way left employees owning a total of \$328.75. Pam inquired if the White County Housing Authority would absorb the \$328.75, due to the incorrect information provided by IMRF. The board agreed for WCHA to absorb the employee portion of \$328.75 for the employee Year End Bonuses and a Motion made by Commissioner Ford, seconded by Commissioner Nelson. Motion approved unanimously.
